RESOLUTION

October 15, 2025

WHEREAS, a current contract exists for the bid titled REFURBISHED STORAGE CONTAINERS which was awarded on November 6, 2024 and assigned contract number B2024-156; and

WHEREAS, the contract terms included an award period of one (1) year and the County reserved the right to extend the term of the contract for one (1) additional year by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Roads Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and Phoenix Contracting, LLC has agreed to such terms in writing.

WHEREAS, pursuant to N.J.A.C. 5:30-5.4, the County has established a reasonable estimated maximum dollar value of \$27,556.00 for the term of this contract, based on historical procurement data for comparable goods or services. The County further reserves the right to increase quantities by up to twenty percent (20%) of the maximum awarded amount at the unit prices bid, in accordance with N.J.A.C. 5:30-11.3; and

WHEREAS, funds for the materials or services described herein shall be made available through operating and expense (O&E) accounts, trust accounts, grant accounts, or capital accounts maintained by, but not limited to, the following departments: Roads Department.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Phoenix Contracting, LLC, accepting their request for the continued furnishing and delivery of REFURBISHED STORAGE CONTAINERS for the extended contract period of November 6, 2025 through November 5, 2026 under the same terms and conditions.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Roads Department, and Phoenix Contracting, LLC .
