RESOLUTION

December 3, 2025

WHEREAS, on August 6, 2025, the Ocean County Board of Commissioners adopted a Resolution authorizing the use of Competitive Contracting for Benefits Administrator Services; and

WHEREAS, Competitive Contracting Procedures were followed in accordance with N.J.S.A. 40A:11-4.3 to procure services aimed at managing the County's medical and prescription benefits plan in a manner that would be both cost-effective and comprehensive; and

WHEREAS, the Ocean County Department of Employee Relations received five (5) responses for Benefits Administrator Services; and

WHEREAS, after receipt and examination of the proposals received, the Employee Relations Department has recommended to reject all proposals pursuant to N.J.S.A. 40A:11-13.2(c) as the governing body has decided to abandon the project for provision or performance of the goods or services.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Competitive Contract proposals received for Benefits Administrator Services are hereby rejected, pursuant to N.J.S.A. 40A:11-13.2(c), as the governing body has decided to abandon the project for provision or performance of the goods or services.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to Ocean County Counsel, County Auditor, Department of Purchasing, Department of Finance, and the Department of Employee Relations.
