RESOLUTION

March 15, 2023

WHEREAS, on January 31, 2023, pursuant to legal advertisements therefor, one sealed bid was received for the furnishing and delivery of FIRE EXTINGUISHERS, FIRE ALARM SYSTEMS, FIRE SUPPRESSION & SPRINKLER SYSTEMS MAINTENANCE, SERVICE AND REPAIR, NO. II for the County of Ocean; and

The County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the furnishing and delivery of Fire Extinguishers, Fire Alarm Systems, Fire Suppression & Sprinkler Systems Maintenance, Service and Repair No. II, for all rejected Items, for the County of Ocean for the contract period of two (2) years from date of award through March 14, 2025, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15.
