The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Capella Construction, Inc. accepting their bid in the total amount of \$793,987.00, in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within one hundred, fifty (150) calendar days. The Contractor is put on notice that if a winter shutdown period between December 15th and March 1st is required due to weather conditions, there shall be no additional payment for Demobilization/Remobilization resulting from the winter shutdown.
- 2. The Department of Finance has certified that funds are available in Account No. 422-185-X214 in the amount of \$793,987.00 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.
- 3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2025-108E.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to each of the following:

- a. County Auditor;
- b. County Department of Purchasing;
- c. Department of Finance; and
- d.
