RESOLUTION
December 20, 2023

WHEREAS, the County of Ocean owns Ocean County Park in Lakewood Township, NJ; and

WHEREAS, the Department of Parks & Recreation desires to engage a firm to provide Engineering Design Services to produce an existing conditions and utility survey for the redevelopment of the park; and

WHEREAS, the Consultant Selection Review Committee recommended twenty three (23) firms as qualified to provide Engineering Design Services to be performed on an as-needed basis, where and as directed by Ocean County; and

WHEREAS, the Ocean County Board of Commissioners qualified twenty three (23) firms as eligible to provide Engineering Design Services by resolution dated September 20, 2023 referred to as contract number QP2023-108; and

WHEREAS, the County of Ocean has received a proposal from Colliers Engineering & Design, 101 Crawford's Corner Rd. Suite 3400 Holmdel, NJ 07733; and

WHEREAS, Colliers Engineering & Design, submitted a proposal for Engineering Design Services in the lump sum fee not to exceed EIGHTY FIVE THOUSAND SIX HUNDRED DOLLARS AND ZERO CENTS (\$85,600.00); and

WHEREAS, funding is available for these services in the Redevelopment of Various Parks Account, Account No's 301-250-C719 & 301-250-X116; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The County Purchasing Agent is hereby authorized to issue a Purchase Order for Engineering Design Services to Colliers Engineering & Design to provide an existing conditions and utility survey for the redevelopment of Ocean County Park, Lakewood Township, in an amount not to exceed EIGHTY FIVE THOUSAND SIX HUNDRED DOLLARS AND ZERO CENTS (\$85,600.00) from the Redevelopment of Various Parks Account, Account No's. 301-250-C719 & 301-250-X116
2. Certified copies of this Resolution shall be made available to County Administrator, County Finance Director, County Auditor, County Counsel, County Parks Director, and Colliers Engineering & Design.
