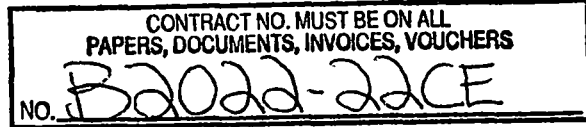

RESOLUTION

WHEREAS, on January 19, 2022, a contract was awarded to Constellation NewEnergy, Inc. for the furnishing and delivery of ELECTRIC GENERATION SUPPLY SERVICE FROM NJBPU LICENSED THIRD PARTY ELECTRIC SUPPLIERS, and assigned Contract No. B2022-22CE; and

WHEREAS, due to a clerical error, the County Purchasing Agent has recommended to this Board that an Amendment to the resolution is necessary, to reflect the correct kWh rate.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The resolution dated 1/19/2022 is hereby amended to reflect the correct rate of Constellation NewEnergy, Inc. for Item No. 2 at \$0.0213/kWh for Atlantic City Electric Accounts for a 24 Month Term.
