RESOLUTION

January 18, 2023

WHEREAS, on December 28, 2022, pursuant to legal advertisements therefor, sealed bids were received for the furnishing and delivery of AGRICULTURAL SUPPLIES NO. II for the County of Ocean; and

WHEREAS, at the advertised time, one response was received from the following bidder:

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has now recommended to this Board that the sole bid received be rejected as unresponsive. No bids were received on Item Nos. 35, 57, 80, 84, 92, 101, 106, 107, 108, 109, 111 and 115. Recommendation is made to reject Item Nos. 110, 112, 113, 114, 116, 117, 118, 119, 120, 121 and 122.

WHEREAS, N.J.S.A. Chapter 40A:11-5(3) provides that, in the event no qualified bids are received on two occasions, a governing body may enter into a negotiable contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. Upon recommendation of the County Purchasing Agent, the sole bid received for Agricultural Supplies No. II is hereby rejected.
2. The County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the furnishing and delivery of Agricultural Supplies No. II, in accordance with N.J.S.A. 40A:11-5(3) for all no bid and rejected bid Item Nos. for the contract period from date of award through December 31, 2023, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance, Parks Department and SiteOne Landscape Supply, the sole bidder.
