WHEREAS, additional funds are available to increase these support services from accounts maintained by the Ocean County Office of Senior Services; and

WHEREAS, the original amount of the contract \$274,882.00 was amended on November 02, 2022 to increase the total amount to \$290,927.00; and

WHEREAS, the amended amount of \$290,927.00 is now amended to increase the total amount to \$316,292.00; and

NOW, THEREFORE, BE IT RESOLVED, by the **OCEAN COUNTY BOARD OF COMMISSIONERS, STATE OF NEW JERSEY**, that the contract dated February 02, 2022 is now amended to increase their contract for services as follows:
