**RESOLUTION**

**WHEREAS**, on November 19, 2025, the County of Ocean awarded **UNIFORMS FOR LAW ENFORCEMENT OFFICERS**, Contract B2025-159, to Action Uniform Co., LLC.; and

**WHEREAS**, the Purchasing Department has received notification that Action Uniform Co., LLC has been sold to Galls, LLC, and that pursuant to a Bill of Sale and Assignment executed in connection therewith, Contract B2025-159 has been assigned to Galls, LLC; and

**WHEREAS**, Galls, LLC has confirmed that it shall assume all duties, responsibilities, liabilities, obligations, and performance requirements under Contract B2025-159 without modification, and that there shall be no changes to pricing, scope of services, or contract terms;

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY** that the Director and Clerk of the Board are hereby authorized to execute an Amendatory Contract for **UNIFORMS FOR LAW ENFORCEMENT OFFICERS**, Contract B2025-159, with the new contract vendor Galls, LLC, 1340 Russell Cave Rd., Lexington, KY 40505, (800) 477-7766, with all other terms and conditions to remain in full force and effect for the duration of the contract term; and

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the County Auditor, Department of Purchase, Department of Finance, and Galls, LLC.
