RESOLUTION

WHEREAS, on January 21, 2026, a Resolution was adopted awarding a Purchase Order to Dynamic Traffic, LLC to provide On-Call Traffic Engineering Professional Services for Construction Support Services related to the Construction of Intersection Improvements at County Route 625 (Ocean Gate Drive) and C.R. 2 (Mill Creek Road)/C.R. 4 Veeder Lane, Township of Berkeley County of Ocean, in an amount not to exceed \$30,000.00, under Contract No. QP2025-41; and

WHEREAS, due to a scrivener's error, it is now necessary to amend the Resolution to authorize the execution of an Agreement with Dynamic Traffic, LLC to provide such services.
