RESOLUTION

December 18, 2024

WHEREAS, professional services are needed to provide Professional Medical Services for County of Ocean during Calendar Year 2025; and

WHEREAS, the Consultant Selection Review Committee has recommended that an agreement for professional medical services be awarded to BHMG Corp Care: Ocean Hub (aka RWJ Barnabas Health) on the basis of the quality of their proposal; and

WHEREAS, BHMG Corp Care: Ocean Hub (aka RWJ Barnabas Health) has significant knowledge and experience in providing medical services for the public service employment and has expertise in the employment procedures required by the New Jersey Department of Personnel as well as the Federally mandated Drug and Alcohol Program; and

WHEREAS, the Local Public Contracts Law authorizes the award of such contracts for such Professional Services pursuant to the provisions of N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, partial funds for these services will be made available upon the adoption of the 2025 Temporary County Budget with the balance to be available contingent upon adoption of the 2025 County Budget and funding shall be made from the Account No. 016-045-4035; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of the Board are hereby authorized and directed to execute an Agreement with BHMG Corp Care: Ocean Hub (aka RWJ Barnabas Health), 1195 Rt. 70, Lakewood, NJ 08701, in an amount not to exceed \$40,000.00, for the provision of Professional Medical Services for County of Ocean during Calendar Year 2025, as more specifically set forth in the contract.
2. This Agreement is awarded as a professional service in accordance with N.J.S.A. 40A:11-5 of the local Public Contracts Law.
3. The contract number shall be placed on all papers, documents, invoices and vouchers pertaining to this Agreement.
4. Certified copies of this Resolution, together with a copy of the Agreement executed by both parties, shall remain on file and be available for public inspection in the Office of the Clerk of the Board of Commissioners.

5. A notice of this action shall be published once as required by law.
6. Certified copies of this Resolution shall be made available to County Counsel, County Auditor, Finance Department, Purchasing Department, Employee Relations, and BHMG Corp Care: Ocean Hub (aka RWJ Barnabas Health).
