WHEREAS, a current contract exists for the bid titled LOCKSMITH SERVICES FOR SECURITY LOCKING SYSTEMS AND DETENTION EQUIPMENT NO. II which was awarded on April 19, 2023 and assigned contract number B2023-70; and

WHEREAS, the contract terms included an award period of one (1) year and the County reserved the right to extend the term of the contract for one (1) additional year by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Buildings and Grounds Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and Northstar Prison Maintenance and Repair LLC has agreed to such terms in writing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Northstar Prison Maintenance and Repair LLC, accepting their request for the continued furnishing and delivery of LOCKSMITH SERVICES FOR SECURITY LOCKIGN SYSTEMS AND DETENTION EQUIPMENT NO. II for the extended contract period of April 19, 2024 through April 18, 2025 under the same terms and conditions.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Buildings and Grounds Department, and Northstar Prison Maintenance and Repair LLC.
