WHEREAS, on February 10, 2026, the Ocean County Board of Commissioners authorized the award of a Contract for the furnishing and delivery of REPAIR SERVICES FOR VEHICLES AND EQUIPMENT WITH GVWR 15,000 LBS OR GREATER, and was assigned Contract No. B026-34; and

WHEREAS, the County Purchasing Agent has now recommended that the Contract be rescinded from Schimpfs Garage LLC, and that Item Nos. 73, 74, 75, 76, 77, 78, 79, 80, 81, 88 and 89 be rescinded as the vendor is unable to honor their contract pricing.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY that Contract No. B2026-34 awarded to Schimpfs Garage LLC, for the furnishing and delivery of REPAIR SERVICES FOR VEHICLES AND EQUIPMENT WITH GVWR 15,000 LBS OR GREATER, Item Nos. 73, 74, 75, 76, 77, 78, 79, 80, 81, 88 and 89, are hereby rescinded. They will not be rebid.
