

### RESOLUTION

#### February 1, 2023

WHEREAS, a current contract exists for the bid titled GOLF CARTS FOR OCEAN COUNTY GOLF COURSES NO. II which was awarded on April 1, 2021 and assigned contract number B2021-43; and

WHEREAS, the contract terms included an award period of thirty-six (36) months and the County reserved the right to extend the terms of the contract two (2) additional twelve (12) month periods by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Parks Department is requesting approval to extend the current contract for one (1) additional year as mentioned above and KLBL Inc. dba Vic Gerard Golf Cars has agreed to such terms in writing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that:

1. The Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with KLBL Inc. dba Vic Gerard Golf Cars accepting their request for the continued furnishing and delivery of GOLF CARTS FOR OCEAN COUNTY GOLF COURSES NO. II for the extended contract period of April 1, 2024 through March 31, 2025 under the same terms and conditions.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Parks Department, and KLBL Inc. dba Vic Gerard Golf Cars.
