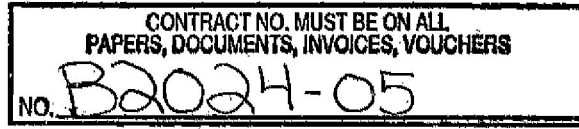

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has now recommended to this Board that the lowest qualified bid, according to specifications, in each instance, be accepted namely that of, EARLE ASPHALT COMPANY; FIORE PAVING CO., INC. and RIVER FRONT RECYCLING & AGGREGATE, LLC. Secondary contracts will be solicited from other bidders at the low bidder's rate. Services under secondary contracts will be requested from next low bidders until the needs of the County are met.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract, accepting the bid for the Hiring of Various Paving Equipment for the Road Department, County of Ocean, for the contract period from date of award through February 6, 2025, a period of one (1) year or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15. The County reserves the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractor with no increase in base price.

A. EARLE ASPHALT COMPANY for one (1) items, to wit:

ITEM NO. 3.

For a Total Lump Sum Award Section III (Item # 3) of \$120,000.00.

This vendor has extended this contract to County Cooperative Contract System Participants.

B. FIORE PAVING CO., INC. for two (2) items, to wit:

ITEM NOS. 2 and 2a

For a Total Lump Sum Award Section II (Item #'s 2 and 2a) of \$135,000.00.

This vendor has extended this contract to County Cooperative Contract System Participants.

C. RIVER FRONT RECYCLING & AGGREGATE, LLC for two (2) items, to wit:

For a Total Lump Sum Award Section I (Item # 1) of \$510,000.00. For a Total Lump Sum Award Section IV (Item # 4) of \$135,000.00.

2. Payments for services and equipment to be acquired by this contract shall be made upon the approval of vouchers submitted by the successful bidders in accordance with the requirements of the Board of Commissioners and subject to the Board of Commissioners customary procedures. Delivery shall be made upon receipt of a Purchase Order issued by the Ocean County Department of Purchase, upon which delivery locations and needed quantities shall be indicated.

3. The award of the contract will be to the bidder proposing the lowest lump sum price per section to the County. Secondary contracts will be solicited from other bidders at the low bidder's rate. Services under secondary contracts will be requested from next low bidders until the needs of the County are met.

4. In the event of tie bids pursuant to N.J.S.A. 40A:11-6.1(d), bids are awarded to the bidder(s) in closest distance to the Ocean County Administration Building, 101 Hooper Avenue, Toms River, NJ, using the address indicated on their bid documentation.

5. Funds for the services and equipment shall be available within the following funding source: County Road Department O.E.

6. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2024-05.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance, County Road Department and the successful bidders.
