RESOLUTION

December 4, 2024

WHEREAS, on December 20, 2023 County of Ocean awarded a Contract to County Business Systems Inc., to provide New Vision Software, Upgrades, Enhancements and Maintenance Services for Document Recording and Indexing System, and was assigned Contract No. CP2023-140; and

WHEREAS, an amendment to the Resolution to include the Digital Imaging and Conversion Services was adopted on May 1, 2024; and

WHEREAS, the services for backfile scanning, conversion, loading and indexing the Ocean County Deed books for the years 1954 through 1959 were anticipated, but inadvertently not expressly set forth in the awarding resolution of December 20, 2023; and

WHEREAS, these services are necessary; and

WHEREAS, services shall be provided on an as-needed basis, with funding available in Trust Account No. 219-055-0016 and Account No. 016-055-4022.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY that Resolution No. 2023001886 awarding a Contract to County Business Systems Inc., to provide New Vision Software, Upgrades, Enhancements and Maintenance Services for Document Recording and Indexing System is hereby amended to include the backfile scanning, conversion, loading and indexing of the Ocean County Deed Books from 1954 through 1959.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to Ocean County Counsel, County Comptroller; Director, Dept. of Management and Budget, County Clerk, and County Business Systems, Inc.
