RESOLUTION

WHEREAS, on December 20, 2023 County of Ocean awarded a Contract to County Business Systems Inc., to provide New Vision Software, Upgrades, Enhancements and Maintenance Services for Document Recording and Indexing System, and was assigned Contract No. CP2023-140; and

WHEREAS, it is necessary to amend the Resolution to include the Digital Imaging and Conversion Services to be provided on an as-needed basis at the following rates:

Conversion, Indexing and Merging of Land Records: \$0.08/per image

Conversion of Miscellaneous Records from paper to Digital Images with Security Microfilm: \$0.24/per image

Security Microfilm Images from Electronic Digital Images: \$0.055/per image

Laser Printing Services per page: \$0.11/Each

Laser Printing Services Record Book Binders: \$54.00

Laser Printing Services Sorting, Lettering & Installation in permanent Record Books: \$0.026/per page; and

WHEREAS, funding for the Digital Imaging and Conversion Services to be provided on an as-needed basis is available from Account No. 016-055-40220.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY that Resolution No. 2023001886 awarding a Contract to County Business Systems Inc., to provide New Vision Software, Upgrades, Enhancements and Maintenance Services for Document Recording and Indexing System is hereby amended to include the Digital Imaging and Conversion Services listed above.
