

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Walters Marine Construction, accepting their bid in the total amount of \$778,546.40, in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within One hundred forty (140) calendar days.
- 2. The Department of Finance has certified that funds are available in Account No. 415-185-C808 in the amount of \$778,546.40 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.
- 3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2023-86E.
- 4. BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to each of the following:
  - a. County Auditor;
  - b. County Department of Purchasing;
  - c. Department of Finance; and
- d. County Engineer who shall see that the successful bidder enters into a proper contract for the faithful performance of their bid and that said contract is duly filed with the Clerk of this Board; and who shall see that the successful bidder furnishes to the County of Ocean a properly executed surety company bond for the faithful performance of their contract.
