## RESOLUTION

November 6, 2024

WHEREAS, Contract No. B2023-98A was awarded on June 21, 2023 to Gavan General Contracting Inc., in connection with the project known as JAIL KITCHEN RENOVATIONS FOR OCEAN COUNTY, NO. II, County of Ocean, State of New Jersey; and

WHEREAS, Change Order No. 1 was awarded on May 1, 2024, an increase to the contract in the amount of \$41,632.00; and

WHEREAS, it has been determined that revisions to the contract are now necessary for additional work as outlined in:

- COR #2: Temporary wall and propane for temporary kitchen trailer, for \$13,483.00.
- COR #3: Material and labor increase due to phasing, for \$18,000.00.
- COR #4: Coring drain and infilling slab, for \$8,200.00.
- COR #5: Plumbing disconnection and reconnection of kitchen equipment, for \$5,585.00.
- COR #6: Credit for deduction of exhaust fan, for \$1,910.00.

WHEREAS, the total costs of above referenced CRP's in the amount of \$43,358.00 shall result in an increase to the contract sum with funding available in Account No. 016-010-6040; and

WHEREAS, the Consulting Architect, Yezzi Associates, has duly filed with the Board a request for Change Order stating the facts involved and certifying that the proposed Change Order is consistent with the regulations for such Change Orders promulgated by the State Department of Community Affairs Division of Local Government Services, under the authority of N.J.S.A. 52:27BB-32; and

WHEREAS, the Contractor has agreed to accept these changes to the Contract.

THEREFORE, BE IT RESOLVED, by BOARD COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Contract amount shall be increased in the amount of \$43,358.00 with funding available in Account No. 016-010-6040.

2. Yezzi Associates is hereby authorized to issue Change Order No. 2 to Gavan General Contracting Inc., in connection with the project known as Jail Kitchen Renovations for Ocean County, No. II.

- 3. The Director and Clerk of the Board are hereby authorized and directed to enter into an Amendatory Contract with Gavan General Contracting Inc., 92 Forest Drive, Lakewood, NJ 08701 to cover Change Order No. 2 and to provide additional information and furnish such documents as may be required.
- 4. The Contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2023-98A.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made. available to the Ocean County Auditor, County Management & Budget Department, County Finance Department, County Buildings & Grounds Department, Yezzi Associates, and Gavan General Contracting, Inc.
