RESOLUTION

December 21, 2022

WHEREAS, the County of Ocean has funds available for **DISABILITY SERVICES PROGRAMS** which would provide community education and awareness activities and services designed to reduce isolation and increase connectivity for adults and children living with disabilities; and

WHEREAS, on September 21, 2022, the Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of a **DISABILITY SERVICES PROGRAMS** provider; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, the Ocean County Department of Human Services has received and reviewed proposals for the services listed above and recommends that an Agreement be awarded to **OCEAN PARTNERSHIP FOR CHILDREN**, 36 Washington Street, Toms River, New Jersey 08753 to provide such services, for January 1, 2023 through December 31, 2023, with an option to extend up to four (4) additional twelve (12) months periods, as more specifically set forth in the Agreement; and

WHEREAS, funds up to the total amount of \$83,250.00 will be appropriated for these services as follows:

WHEREAS, funding for Innovative Disability Services, in the amount of \$33,750.00, shall be made available upon adoption of the Ocean County American Rescue Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, AS FOLLOWS:

- 1.) The Director and Clerk of the Board are hereby authorized to enter into an Agreement with **OCEAN PARTNERSHIP FOR CHILDREN**, to provide **DISABILITY SERVICES PROGRAMS**, contingent upon the availability of funds.

- 2.) The contract number must be placed on all papers, documents, invoices and vouchers pertaining to this Agreement.
- 3.) The Director and the Clerk of the Board are hereby authorized and directed to execute any necessary subsequent related documents.
- 4.) A certified copy of this Resolution, together with a copy of the Agreement executed by the parties, shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.
- 5.) Certified copies of this Resolution shall be made available to County Counsel, County Comptroller, Department of Human Services, and Ocean Partnership for Children.
