**RESOLUTION**

**December 4, 2024**

**WHEREAS**, on May 3, 2023, the Ocean County Board of Commissioners awarded a Competitive Contract to **Bright Harbor Healthcare**, 687 Route 9, Bayville, New Jersey 08721 to provide Child and Adolescent Grief Programming, as more specifically set forth in the Agreement, and assigned Contract No. CC2023-75; and

**WHEREAS**, on October 18, 2023, an amendatory agreement was executed to correct the service term and specifically delineate the requisite minimum insurance coverages; and

**WHEREAS**, the Agreement was for an 8 month period and, at the successful completion, two (2) one-year extensions can be exercised; and

**WHEREAS**, on December 6, 2023, the Agreement was extended for January 1, 2024, through December 31, 2024; and

**WHEREAS**, the Ocean County Department of Human Services desires to utilize the option to extend the Agreement for January 1, 2025 through December 31, 2025; and

**WHEREAS**, funds up to the total amount of \$50,400.00 will be appropriated for these services, as follows:

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:**

- 1) The Director and Clerk of the Board are hereby authorized to enter into and execute an Agreement with Bright Harbor Healthcare for the period of January 1, 2025, through December 31, 2025, to provide Child and Adolescent Grief Programming, contingent upon the availability of funds.
- 2) The contract number CC2023-75 must be placed on all papers, documents, invoices and vouchers pertaining to said agreement.
- 3) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the Ocean County Department of Finance, County Auditor, Department of Human Services, and Bright Harbor Healthcare.
