RESOLUTION

May 3, 2023

WHEREAS, the COUNTY of OCEAN, has funds available for Child and Adolescent Grief Programming which would facilitate training, consultation, and startup associated with grief support groups and grief interventions for children and adolescents; and

WHEREAS, on December 7, 2022, the Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of Child and Adolescent Grief Programming; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, the Ocean County Department of Human Services has received and reviewed proposals for the services listed above and recommends that an Agreement be awarded to Bright Harbor Healthcare, 687 Route 9, Bayville, New Jersey 08721 to provide such services, for May 1, 2023 through December 31, 2023, with an option to renew up to one (1) additional twelve (12) month period, as more specifically set forth in the Agreement; and

WHEREAS, funds up to the total amount of \$50,400.00 will be appropriated for these services, contingent upon the availability of funds, as follows:
