WHEREAS, on September 3, 2025, pursuant to legal advertisements therefor, sealed bids were received for furnishing and delivery of PENAL INSTITUTIONAL SUPPLIES NO. II for the County of Ocean; and

WHEREAS, on October 15, 2025, Contract B2025-147, Item Nos. 12 and 34 were awarded to ICS JAIL SUPPLIES, INC., and

WHEREAS, the County Purchasing Agent has now requested Contract B2025-147, Item Nos. 12 and 34 awarded to ICS JAIL SUPPLIES, INC be rescinded due to vendor being unable to honor their contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The aforementioned Resolution and Contract dated October 15, 2025 awarding Item Nos. 12 and 34 awarded ICS JAIL SUPPLIES, INC are hereby rescinded.
2. The Director and Clerk of this Board are hereby authorized and directed to enter into amendatory contracts with CHARM-TEX, INC., for Item No. 12 and BIENALI PROMOTIONS LLC for Item No. 34, the next lowest qualified bidders. These vendors have extended the contracts to County Cooperative Contract System Participants, Identifier No. CK-02-OC.
3. All other provisions of Contract No. B2025-147 shall remain in full force and effect.
4. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2025-147.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Corrections Department, Juvenile Services and the successful bidders.
