RESOLUTION

December 4, 2024

WHEREAS, the Ocean County Board of Commissioners has developed a Recovery Plan for the purposes of the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) through the American Rescue Plan Act (ARPA), a component of which is to facilitate community awareness, prevention education, and resource campaigns in an effort to prevent suicide deaths among youth; and

WHEREAS, on July 19, 2023, the Ocean County Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of Youth Suicide Prevention Programming; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, on September 20, 2023, a Competitive Contract was awarded to Society for the Prevention of Teen Suicide, Inc., 110 West Main St., Freehold, NJ 07728 by the Ocean County Board of Commissioners to provide **Youth Suicide Prevention Programming** for the period of October 1, 2023 through December 31, 2024, with an option to renew up to one (1) additional twelve month period, as more specifically set forth in the Agreement, and assigned Contract No. CC2023-111; and

WHEREAS, the County now wishes to extend the contract with Society for the Prevention of Teen Suicide, Inc. for a twelve (12) month period at no additional cost from January 1, 2025 through December 31, 2025 to allow the vendor to complete performance and contract deliverables; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1) The Director and Clerk of the Board are hereby authorized to execute an Amendatory Agreement with Society for the Prevention of Teen Suicide, Inc. to provide Youth Suicide Prevention Programming for the period of January 1, 2025 through December 31, 2025.
- 2) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.
- 3) The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Department of Finance, County Auditor, Department of Human Services, and Society for the Prevention of Teen Suicide, Inc.
