RESOLUTION

WHEREAS, there exists a need to provide Mentoring Services as proposed by the 2021 Comprehensive Youth Services Commission Plan approved by the Ocean County Board of Chosen Freeholders on October 7, 2020; and

WHEREAS, N.J.S.A. 40A:11 – 4.3 et seq. authorizes the procurement of certain specialized goods and services through a Competitive Contracting process; and

WHEREAS, on October 2, 2002, the Ocean County Board of Chosen Freeholders adopted a resolution authorizing the utilization of Competitive Contracting Procedures; and

WHEREAS, on October 21, 2020, the Ocean County Board of Chosen Freeholders adopted a resolution updating the titles of the competitive contracts, the scope of work and services shall remain the same; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40:11-4.3 for the services listed above; and

WHEREAS, the Ocean County Youth Services Commission has received and reviewed proposals for such services and recommends an Agreement with Youth Advocate Programs, Inc. to provide such services; and

WHEREAS, funding is available in the amount of \$118,305.00, contingent upon the adoption of the 2021 Temporary Budget, of which \$98,961.00 shall be appropriated from account number 017-819-Y084 and \$19,344.00 shall be appropriated from account number 017-819-Y031 to cover the cost of the 2021 contract; and

WHEREAS, funds cover the cost of the contract for future years will be encumbered upon the approval and adoption of future County Budgets for those years and certification of funds by the County Comptroller; and

WHEREAS, the County reserves the right to terminate this contract at any time during the contract term if sufficient funds are not available and appropriated to cover the cost of same.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF CHOSEN FREEHOLDERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Freeholder Director and the Clerk of the Board are hereby authorized and directed to enter into and execute an Agreement with Youth Advocate Programs, Inc., 2007 North Third Street, Harrisburg, PA 17102 in the amount of \$118,305.00 for the provision of the services set forth above.

2. The term of this Agreement will be for a period of twelve (12) months commencing

on January 1, 2021 and expiring on December 31, 2021, with an option to extend

the contract up to four (4) additional twelve-month periods, or as otherwise directed

by the New Jersey Juvenile Justice Commission based on positive monitoring,

submission of required reports, approval of each year's contract by the Youth

Services Commission and pending the availability and appropriation of sufficient

funds to meet the obligations of Ocean County hereunder.

3. Copies of the Resolution together with a copy of the Agreement for such services

set forth above shall be placed on file and be kept available for public inspection in

the Office of the Clerk of the Board during normal business hours.

4. The contract number shall be placed on all papers, documents, invoices and

vouchers pertaining to this Agreement.

5. The Freeholder Director and the Clerk of the Board are hereby authorized and

directed to execute any necessary subsequent related documents.
