RESOLUTION

August 6, 2025

WHEREAS, the Ocean County Board of Commissioners require the services of Assistant County Counsels; and

WHEREAS, on June 4, 2025 the County qualified six (6) firms as eligible to provide Assistant County Counsel Services, on a project specific basis; and

WHEREAS, it is now the desire of the Board to appoint Jean L. Cipriani, Esq. with the firm, Rothstein, Mandell, Strohm, Halm & Cipriani, P.A. as Assistant County Counsel for the period of August 7, 2025 through December 31, 2025; and

WHEREAS, the retainer costs for Assistant County Counsel services, in an amount not to exceed \$20,000.00 per year, shall be appropriated from General County Counsel Services: 016-030-4010; and

WHEREAS, for all other legal services to be rendered: General County Counsel Services: 016-030-4010, in an amount not to exceed \$400,000.00; and

WHEREAS, the Local Public Contracts Law requires that the Resolution authorizing the award of a contract for professional services and the contract itself must be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. Jean L. Cipriani, 98 E Main Street, Toms River, New Jersey 08753 is hereby appointed Assistant County Counsel, effective August 7, 2025 through December 31, 2025 in accordance with the terms and conditions set forth in the Professional Service Agreement on file in the Office of the Clerk of the Board.
- 2. The Director and Clerk of the Board are hereby authorized and directed to enter into and execute a Professional Service Agreement with Jean L. Cipriani, Esq., a copy of which is on file with the Clerk of the Board.
- 3. This Agreement is awarded in accordance with N.J.S.A. 40A:11-5, because legal services are professional in nature and because Jean L. Cipriani is a licensed attorney, authorized to practice law in the State of New Jersey.
- 4. This Agreement is also awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq.
- 5. A certified copy of this Resolution, together with a copy of each of the Professional

Service Agreement executed by the parties, shall be placed and kept on file at the Office of the Clerk of the Board of Commissioners.

6. A notice of this action shall be printed in a local newspaper.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be forwarded to Ocean County Counsel, Ocean County Comptroller, and Jean L. Cipriani, Esq., Assistant County Counsel.
