RESOLUTION October 4, 2023

WHEREAS, on February 7, 2023, the New Jersey Department of Environmental Protection (NJDEP) terminated the Ground Water Remedial Action Permit (#RAP 170001) issued per N.J.A.C. 7:26E, related to case # 13-02-05-1128-45 at the Cedar Bridge Tavern County Historic Site, Barnegat NJ; and

WHEREAS, as part of the termination the monitoring wells on site need to be abandoned by a certified well driller in the State of New Jersey and be reported by an Environmental Consultant, and

WHEREAS, the Board considers it necessary and desirable to engage an Environmental Consulting Services firm from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on August 3, 2022; (QP2022-111); and

WHEREAS, Mott MacDonald, LLC is qualified to provide the required Environmental Consulting Services in accordance with their project specific proposal at a not to exceed cost of Eight Hundred Ten Dollars & Zero Cents (\$810.00); and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. It authorizes the expenditure for Environmental Consulting Services to Mott MacDonald, LLC at a not to exceed cost of Eight Hundred Ten Dollars & ZERO CENTS (\$810.00) from the Cedar Bridge Tavern Preservation, Restoration: Account Number 409-250-C603.
