RESOLUTION

**December 3, 2025**

**WHEREAS**, on August 6, 2025, the Ocean County Board of Commissioners adopted a Resolution authorizing the use of Competitive Contracting services for a qualified Health Insurance Provider for Medical and Prescription Benefits; and

**WHEREAS**, Competitive Contracting Procedures were followed in accordance with N.J.S.A. 40A:11-4.3 to procure services aimed at providing medical and prescription benefits to County employees in a cost effective and comprehensive manner that meets the County's healthcare coverage needs; and

**WHEREAS**, the Ocean County Department of Employee Relations received two (2) responses for Health Insurance Provider for Medical and Prescription Benefits; and

**WHEREAS**, after receipt and examination of the proposals received, the Employee Relations Department has recommended to reject all proposals pursuant to N.J.S.A. 40A:11-13.2(c) as the governing body has decided to abandon the project for provision or performance of the goods or services.

**NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the Competitive Contract proposals received for Health Insurance Provider for Medical and Prescription Benefits are hereby rejected, pursuant to N.J.S.A. 40A:11-13.2(c), as the governing body has decided to abandon the project for provision or performance of the goods or services.
