WHEREAS, on July 29, 2025, pursuant to legal advertisements therefor, sealed bids were received for the CONSTRUCTION OF TRAFFIC SIGNAL AT THE INTERSECTION OF C.R. 571 (RIDGEWAY ROAD) AND BEACON STREET, MANCHESTER TOWNSHIP, County of Ocean, State of New Jersey; and

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has referred all bids to the County Engineer for study and recommendation to the Board; and

WHEREAS, the County Engineer has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, EARLE ASPHALT COMPANY, be accepted for the Construction of Traffic Signal at the Intersection of C R. 571 (Ridgeway Road) and Beacon Street, Manchester Township.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Earle Asphalt Company, accepting their bid in the total amount of \$1,142,513.13, in accordance with plans and specifications prepared by the County Engineer. All work under this Contract shall be completed within one hundred, seventy-five (175) calendar days. The Contractor is put on notice that if a winter shutdown period between December 15th and March 1st is required due to weather conditions, there shall be no additional payment for Demobilization/Remobilization resulting from the winter shutdown.
- 2. The Department of Finance has certified that funds are available in Account No. 301-185-X314 for the amount of \$97,950.00, and in Account No. 424-185-X314 for the amount of \$1,044,563.13 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.
