RESOLUTION

July 29, 2026

WHEREAS, on December 17, 2025, Resolution No. 2025001833 was adopted by the Ocean County Board of Commissioners awarding a Contract to RideCo US, Inc. to provide Paratransit Scheduling and Dispatching Software for the Ocean County Transportation Services (Ocean Ride), and was assigned Contract No. QP2025-63; and

WHEREAS, the Resolution and Contract contained a scrivener's error, reflecting the inability to purchase additional hardware and provisions of the Contract for the period of the three (3) year term commencing November 21, 2025 and ending November 20, 2028; and

WHEREAS, the County now desires to be able to purchase additional hardware and provisions for vehicles during the duration of the awarded three (3) year contract. This would cover incoming and retired vehicle swap outs issued by Purchase Orders.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. Resolution No. 2025001833 is hereby amended to reflect the option of purchasing additional hardware through Purchase Order only for the duration of the awarded three (3) year contract November 21, 2025 to November 20, 2028.
2. The contract number must be placed on all paper documents, invoices and vouchers pertaining to this Contract.
3. A certified copy of this Resolution shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Counsel, County Auditor, County Comptroller, County Department of Transportation and RideCo US, Inc.
