RESOLUTION

December 17, 2025

WHEREAS, on May 21, 2025, the Ocean County Board of Commissioners adopted Resolution No. 2025000695 qualifying firms as eligible to provide Paratransit Scheduling & Dispatching Software for the Ocean County Department of Transportation Services (Ocean Ride); and

WHEREAS, the Ocean County Department of Transportation Services (Ocean Ride) has determined that a need exists for new Paratransit Scheduling & Dispatching Software (PSDS); and

WHEREAS, the County of Ocean considers it necessary and desirable to award an Agreement from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on May 21, 2025, and referred to as Contract Number QP2025-63; and

WHEREAS, the qualified firms were given the opportunity to interview and provide demonstrations of their Paratransit Scheduling & Dispatching Software to Ocean County and submit their specific cost proposals; and

WHEREAS, the Ocean County Department of Transportation Services (Ocean Ride) has determined that RideCo US, Inc. to be the most qualified to provide the required Paratransit Scheduling & Dispatching Software in accordance with their proposal dated October 22, 2025, at a not to exceed cost of \$1,158,486.00 for a three (3) year period; and

WHEREAS, the funds shall be encumbered for said award in the amount not to exceed \$580,421.00 now available in the 2025 Office of Information Technology Capital Fund under Account No. 016-085-6042, for Year 1 which includes platform implementation/hardware/technology fee/IVR & Swiftly fixed route software beginning November 21, 2025 to November 20, 2026; and

WHEREAS, the balance of funding for said award shall be encumbered upon the adoption of the 2026 and 2027 Temporary County Budgets and the 2026 and 2027 County Budgets, at which time the Department of Finance will notify the appropriate County Officials when funds become available, as follows:

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Director and Clerk of the Board are hereby authorized to execute an Agreement with RideCo US, Inc. for Year 1 services to include platform implementation/hardware/technology fee/IVR & Swiftly fixed route software related to a Paratransit Scheduling & Dispatching Software for the Ocean County Department of Transportation Services (Ocean Ride), with funding available in Account No. 016-085-6042, in the amount of \$580,421.00, with the balance of funding for Year 2 and Year 3 to be made available upon the adoption of the 2026 and 2027 Temporary County Budgets and the 2026 and 2027 County Budgets.
2. The Director & Clerk of the Board are hereby authorized and directed to enter into any necessary subsequent documents with RideCo US, Inc. 10880 Wilshire Boulevard, Suite 1101, Los Angeles, CA 90024.
3. A notice of this action shall be published once as required by law.
4. The Contract number must be placed on all papers, documents, invoices and vouchers pertaining to this award.
5. A certified copy of this Resolution shall remain on file and be available for public inspection at the Office of the Clerk of the Board of Commissioners.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to Ocean County Counsel, County Administrator, County Finance Department, County Purchasing Department, County Office of Information Technology, County Transportation Services Department (Ocean Ride) and RideCo US, Inc.
