RESOLUTION

WHEREAS, on June 4, 2024, pursuant to legal advertisements therefor, sealed bids were received for Item Nos. 75, 76, 77, 78, 79, 80, 81, 82, 83, 84 and 85 for the furnishing and delivery of FIRE EXTINGUISHERS, ALARM SYSTEMS, SUPPRESSION & SPRINKLER SYSTEMS MAINTENANCE, SERVICE AND REPAIR for the County of Ocean; and

WHEREAS, on July 17, 2024, Contract B2024-99, Item Nos. 75, 76, 77, 78, 79, 80, 81, 82, 83, 84 and 85 were awarded to HARRING FIRE PROTECTION LLC.

WHEREAS, the County Purchasing Agent has requested Contract B2024-99, Item Nos. 75, 76, 77, 78, 79, 80, 81, 82, 83, 84 and 85, be rescinded as they were erroneously awarded due to a clerical error.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The aforementioned Resolution and Contract dated July 17, 2024, awarding Item Nos. 75, 76, 77, 78, 79, 80, 81, 82, 83, 84 and 85 to Harring Fire Protection, LLC., is hereby rescinded.

2. All other provisions of the Resolution and contract documents described above shall remain in full force and effect.
