RESOLUTION

November 6, 2024

WHEREAS, Contract No. B2020-113A was entered into on September 2, 2020, with Hilt Construction, Inc., in connection with the project known as PROPOSED EXTERIOR IMPROVEMENTS & RESTORATION TO OCEAN COUNTY P.E.E.R. BUILDING, 129 HOOPER AVENUE, TOMS RIVER, County of Ocean, State of New Jersey; and

WHEREAS, Change Order #1 was awarded on September 1, 2021, the net cost was \$150,238.00.00, of which \$50,000.00 was billed against the Allowance and the remaining amount of \$100,238.00 resulted in an increase to the contract; and

WHEREAS, Change Order #2 was awarded on October 6, 2021, an increase to the contract in the amount of \$61,265.00; and

WHEREAS, Change Order #3 was awarded on January 17, 2024, an increase to the contract in the amount of \$35,236.00; and

WHEREAS, it has been determined that revisions to the contract are now necessary for credits associated with various uncompleted work performed by the County, as well as uncompleted contract site work; and

WHEREAS, these costs result in a total reduction to the contract in the amount of \$25,000.00; and

WHEREAS, the Consulting Architect. Yezzi Associates, has duly filed with the Board a request for Change Order stating the facts involved and certifying that the proposed Change Order is consistent with the regulations for such Change Orders promulgated by the State Department of Community Affairs Division of Local Government Services, under the authority of N.J.S.A. 52:27BB-32; and

WHEREAS, the Contractor has agreed to accept these changes to the Contract.

NOW, THEREFORE, BE IT RESOLVED, by the COUNTY OF OCEAN BOARD OF COMMISSIONERS, STATE OF NEW JERSEY, as follows:

- 1. The Contract amount shall be decreased by \$25,000.00.
- Yezzi Associates is hereby authorized to issue Change Order No. 4 to Hilt Construction, Inc., in connection with the project known as Proposed Exterior Improvements & Restoration to Ocean County P.E.E.R. Building, 129 Hooper Avenue, Toms River, New Jersey.

- 3. The Director and Clerk of the Board are hereby authorized and directed to enter into an Amendatory Contract with Hilt Construction, Inc., 120 Old Camplain Rd, Hillsborough, NJ 08844 to cover Change Order No. 4 and to provide additional information and furnish such documents as may be required.
- 4. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2020-113A.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Management & Budget Department, Finance Department, Buildings & Grounds Department, County Auditor, Yezzi Associates and Hilt Construction, Inc.
