**RESOLUTION**

**May 6, 2026**

**WHEREAS**, by Resolution adopted on March 25, 2026, the Ocean County Board of Commissioners authorized a vendor name change for the contract titled **GOLF CARTS FOR OCEAN COUNTY GOLF COURSES**, Contract B2024-168, from KLBL, LLC d/b/a Vic Gerard Golf Cars to Mid-Atlantic Golf Cars, LLC; and

**WHEREAS**, said Resolution authorized the execution of an amendatory contract to reflect the vendor name change; and

**WHEREAS**, documentation provided by the vendor confirms that the name change represents a change in name only, with no change to ownership, tax identification number, duties, responsibilities, liabilities, pricing, scope of services, or contract terms; and

**WHEREAS**, as such, the execution of an amendatory contract is not required and the vendor name change may be recognized administratively;

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Resolution adopted on March 25, 2026 for contract B2024-168 is hereby amended to remove the requirement authorizing the execution of an amendatory contract related to the vendor name change.
2. The vendor name change from KLBL, LLC d/b/a Vic Gerard Golf Cars to Mid-Atlantic Golf Cars, LLC, located at 281 Squankum Road, Farmingdale, NJ 07727, is hereby acknowledged and accepted as a name change only, with no change to ownership, tax identification number, duties, responsibilities, liabilities, pricing, scope of services, or contract terms.
3. All other terms and conditions of the Resolution adopted on March 25, 2026 shall remain in full force and effect.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Parks and Recreation Department, and Mid-Atlantic Golf Cars, LLC.
