It is further agreed and understood that the COUNTY assumes no obligation to indemnify or save harmless the CONTRACTOR, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the COUNTY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.

## **SCOPE OF WORK**

The Construction Project Manager (CPM) will participate in the review of construction documents, provide input relative to the staging of the project and organize and conduct a preconstruction meeting. The CPM will provide a review of engineering, inspection, estimates and project management services for the duration of the project. The CPM will oversee and coordinate all contractors/subcontractors and utilities during all phases of the project. The CPM will also perform the following tasks:

1. Provide a qualified Resident Engineer and Resident Inspector (part time) who has experience in bridge and highway construction and inspection and possesses communication and coordination skills required to carry out the responsibilities of construction management;
2. Review and provide comments to the County Engineer on the bid specifications, drawings and documents to identify issues prior to their release for competitive bidding;
3. In conjunction with County staff, review bids submitted by the Contractor(s) and make a recommendation of award.
4. In conjunction with the County Engineer, review the Contractor's proposed schedule for all project tasks and activities prior to the issuance of a Notice to Proceed.
5. In conjunction with the County Engineer, coordinate, review and provide recommendations for all shop drawings.
6. Review and provide recommendations for all material questionnaires.
7. Review and approve all requests for payments submitted by the Contractor(s) to the County in accordance with the contract document.
8. Review and prepare all change orders either resulting from unforeseen circumstances or owner initiated prior to submission for approval by the Board of Commissioners.
9. Consult with the County Engineer if any Contractor requests interpretations of the meaning and intent of the drawings and specifications and assist in the resolution of questions which may arise.
10. Endeavor to achieve satisfactory performance from the Contractor. Recommend courses of action to the County when requirements of a contract are not being fulfilled and the non-performing party will not take satisfactory corrective action.
11. Record the progress of the project. Provide written progress reports to the County Engineer including information showing percentages of completion, project budget and the number and amount of approved change orders and maintain a project log.
12. Assist the County Engineer in preparing a punch list of incomplete or unsatisfactory items and a schedule for their completion and assist in determining when the project is substantially complete.
13. Finalize all inspections, estimates and as-built quantities needed to close out the project.

## **ALL SUBMISSIONS MUST INCLUDE THE FOLLOWING MINIMUM INFORMATION:**

1. The introduction background statement should demonstrate the firm's understanding and approach to the project, as well as detail the firm's previous experience with projects of comparable size and complexity.
2. Specific information should be provided that demonstrates familiarity with the following:
  - A. Typical projects that may involve Roadway Reconstruction, Storm Drainage facilities and/or small Bridge Construction
  - B. Permit compliance and monitoring, including environmental knowledge
  - C. Project scheduling and electronic reporting

3. Resumes of staff dedicated to this project should outline all certifications, licenses and relevant experience. At least three (3) recent references shall be provided for both Resident Engineer and Inspector (part time).
4. Proximity to the Ocean County seat is an important selection criteria as it relates to the Consultant's ability to respond to emergency situations, cover overtime and night operations and to provide the County Engineer with frequent in-person updates.

**GENERAL CONDITIONS TO THE PROPOSAL:**

1. Proposer's Experience and Qualifications

- A. The proposer firm must provide an organizational chart specific to those personnel assigned to the project, as well as their qualifications. This shall include, but not be limited to, the resumes, names and phone numbers of assigned personnel, as well as descriptions of similar work and references.
- B. The proposer firm must have a minimum of 10 years experience providing similar services for similar sized institutions and shall include in their proposal their specific experience in providing such services. A list of at least 3 references must accompany all proposals. The County reserves the right to disqualify proposer firms based on experience and/or references. Proposer firms must be prepared to present the County with suitable evidence of their financial standing upon request.
- C. The Resident Engineer shall, at a minimum, be N.I.C.E.T. IV or N.J.P.E. with a documented five years of recent experience as Resident-in-Charge of projects of comparable size and complexity. Additional certifications and/or licenses relative to the type of construction are a plus. The Resident Inspector shall be, at a minimum, a N.I.C.E.T. III with a documented five years of recent experience on projects of comparable size and complexity.
- D. Disclosure of Proposal Contents: All proposals and other material submitted become property of the County and may be returned only at the County's option. Information contained in the proposals will not be disclosed during the evaluation process. Under New Jersey's "Right to Know" laws, public records are required to be open to reasonable inspection. All proposal information, including detailed price and cost information, will be held in confidence during the evaluation process and prior to the time the Notice of Award is issued.

## 2. Conflict of Interest

A. Each proposal shall include a statement indicating whether or not the firm or any individual working on the contract has a possible conflict of interest (e.g. themselves, spouse or child employed by the County of Ocean) and if so, the nature of that conflict. The County reserves the right to cancel the award if any interest disclosed from any source could either give the appearance of a conflict or cause speculation as to the objectivity of the project to be performed by the vendor. The County's determination regarding any question of conflict of interest shall be final.

B. The County may exclude a proposer from submitting a proposal, or may reject a proposer's proposal, after making a written determination that the proposer received payment for assistance in drafting the RFQ, or gained substantial information regarding the RFQ that was not available to the public.

3. Submission of Proposal: As discussed under section "Method of Submission", proposals for **Construction Project Management for Various Road and Bridge Projects in Ocean County, Where and As Directed by the County Engineer**, must be submitted electronically.

4. Understanding the Project: Proposers must provide a comprehensive narrative statement that illustrates their understanding of the requirements of the project and illustrates the methodology that will serve to accomplish the work.

5. Discussions with Proposers: The County may elect to conduct discussions with responsible proposers who submit proposals determined to be eligible for award. The purpose of these discussions will be to clarify and assure proposer's full understanding of, and responsiveness to, the solicitation requirements. Proposers reasonably eligible for award shall be accorded fair and equal treatment with respect to any opportunity for discussion and revision of proposals, and revisions may be permitted after submissions and before award of the contract for the purpose of obtaining best and final offers. In conducting these discussions, the County may not disclose information derived from proposals submitted by competing proposers.

6. Response Format and Content: The RFQ sections that should be submitted and clearly defined are:

7. A statement acknowledging that the proposer shall comply with all conditions outlined. An Officer of the company empowered to bind the company must sign the proposal.

8. The Fee Schedule of Direct Labor Hourly Rates, Overhead, Profit, and Direct Expenses Sheet provided in the RFQ must be properly completed and submitted. **Failure to properly complete this Fee Schedule will be cause for rejection of proposal.** The Fee Schedule of Direct Labor Hourly Rates, Overhead, Profit, and Direct Expenses must include detail of all direct and indirect costs associated with the performance of this hypothetical project. This is a Cost Plus, Not to Exceed contract.

9. The proposal should be brief and to the point referencing only key personnel that are proposed for the project; three or four relevant projects; references and detail of the firm's approach, understanding and experience. Failure to address these items may cause the proposal to be determined as non-responsive and the proposal may be rejected.
10. Exception/Alternate Proposals: To be considered, proposers must follow the instructions outlined in this document. Any exceptions to the terms, conditions or other requirements in any part of the RFQ must be clearly stated in the proposal. Otherwise, the County will consider that all proposals offered are in strict compliance with this RFQ and the successful proposer will be responsible for compliance.
11. Right to Negotiate: After the County's completion of the evaluation process, including any discussion held with proposers during the evaluation process, the County may elect to initiate contract negotiations. The option of whether or not to initiate contract negotiations rests solely on the County. If the County elects to initiate contract negotiations, these negotiations cannot involve changes in the County's requirements or the proposal submitted, which would, by their nature, affect the basis of the source selection and competition previously conducted.
12. Failure to Negotiate: If the selected proposer fails to provide information required to begin negotiation in a timely manner, if the proposer fails to negotiate in good faith, if the County and proposer cannot mutually agree to an acceptable expenditure or if the proposer and the County, after a good faith effort, simply cannot come to terms, the County may terminate negotiations with the proposer initially selected and commence negotiation with the next highest ranked proposer.
13. **Intent:** The County intends to recommend at least six (6) qualified Construction Project Management consultants for Road and Bridge Projects where and as directed by the County Engineer. The construction cost of each project is expected to be between \$500,000.00 and \$5,000,000.00. Currently, it is expected that at least three (3) projects will require Construction Project Management of varying scope and duration. Assignments will be determined by project specific proposal solicitations from firms from the rank listing. Proposals should identify the team members available to the specific assignment along with associated costs to provide the Construction Project Management Services for the specific assignment.

A Purchase Order/Contract will be issued for the specific assignment based upon the submitted quote that is in the best interest of the County determined by the County Engineer at the firm's contract rates. Fees will be paid for on the basis of actual hours worked and not to exceed a defined amount per assignment.

### **AWARD/QUALIFYING VENDOR(S)**

The County of Ocean intends to either award a contract or qualify the vendor or vendors that best meet the needs and interests of Ocean County. The County reserves the right to negotiate the terms and conditions of a contract with the successful vendor or vendors to obtain the most cost advantageous services for the County. When awarding a contract to a qualified vendor, it will be done on a Project Specific basis and a Purchase Order will be generated that will be the contract for that project.

The County reserves the right to reject any or all proposals in accordance with N.J.S.A. 40A:11-13.2, or to waive any informalities and non-material defects in the proposals and to accept any proposal deemed in the best interest of the County.

It is to be understood by the proposer that their proposal is submitted on the basis of specifications prepared by the County and the fact that any proposer is not familiar with these specifications or conditions will not be accepted as an excuse.

## INDEMNITY CLAUSE

The proposer, if awarded a contract, agrees to protect, defend and save harmless the County against any damage for payment for the use of any patented material process, article or device that may enter into the manufacture, construction or form a part of the work covered by either order or contract, and he further agrees to indemnify and save harmless the County from suits or actions of every nature and description brought against it, for, or on account of injuries or damages received or sustained by any party or parties by, or from any of the negligent acts of the contractor, his servants or agents.

## INSURANCE REQUIREMENTS

The contractor shall maintain primary insurance to protect against all claims under Worker's Compensation, Comprehensive General Liability and Automobile. Except for Worker's Compensation, all coverage shall apply as primary coverage with respect to any other insurance or self-insurance program afforded to the County. There shall be no endorsement or modification of this coverage to make it excess over other available insurance/coverage; alternatively, if the CGL and umbrella, excess of reinsurance states that it is pro rata, it shall be endorsed to be primary with respect to the County. Primary coverage shall be subject to approval for adequacy of protection as per the following limits:

### Worker's Compensation

1. Limits according to Worker's compensation Laws of the State of New Jersey.
2. Contractor's Liability not less than \$100,000.

### Comprehensive General Liability

1. Bodily Injury - \$500,000 per person; \$1,000,000 per occurrence.
2. Property Damage - \$1,000,000 per occurrence.

### Comprehensive General Liability shall include the following:

1. Coverage for explosion, collapse or underground hazards.
2. Occurrence basis coverage.
3. Broad form property damage coverage.
4. Coverage for personal injury sustained by any person as a result of an offense directly or indirectly related to the employment of such person by the insured.

### Comprehensive Automobile Liability, if applicable, shall include the following:

Business auto liability insurance or its equivalent with a minimum limit of \$1,000,000 per accident and including coverage for all of the following:

- a. Liability arising out of the ownership, maintenance or use of any auto;
- b. Auto non-ownership and hired car coverage.
- c. Contractor's Worker's Compensation, Comprehensive General Liability and Comprehensive Automobile Liability arising out of subcontractor's operations shall be identical as that listed above.

### Professional Liability

1. Errors and Omissions Coverage - not less than \$1,000,000.

Copies of each insurance certificate shall be furnished to the County with Proposal and must state the County of Ocean is additionally insured.

## **ADDITIONAL INFORMATION**

Payments will be made upon the approval of vouchers submitted by the successful proposer in accordance with the requirements of the Board of Commissioners and subject to the Board of Commissioners customary procedures. The County will not pay interest or late fees regardless of language provided.

The County of Ocean is exempt from any State sales tax or Federal excise tax.

Ocean County Board of Commissioners will make award within sixty (60) days after receipt of proposals.

“All contractors must comply with the provisions of New Jersey Statute Title 40A:11-18, when applicable.”

## **PAY TO PLAY REQUIREMENTS**

Starting in January 2007, all business entities are advised of their responsibility to file an annual disclosure statement of political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if they receive contracts in excess of \$50,000 from public entities in a calendar year. Business entities are responsible for determining if filing is necessary. In the event services are terminated by contract expiration or by voluntary termination by either the Contractor or the County of Ocean, the Contractor shall continue all terms and conditions of said contract for a period not to exceed one month, at the County's request.

## **NEW JERSEY BUSINESS REGISTRATION CERTIFICATE**
