NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into contracts for the furnishing and delivery of Meals, Delivered for the County of Ocean, for the contract period of one (1) year from February 11, 2026 through February 10, 2027, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15.

A. DRIFTWOOD DELI & SUB SHOP for eighteen (18) items, to wit:  
ITEM NOS. 1, 2, 3, 5, 6, 8, 9, 10, 11, 12, 17, 18, 19, 20, 21, 22, 23 and 24.  
This vendor has extended this contract to County Cooperative Contract System Participants, Identifier No. CK-02-OC.

B. LEGACY HOSPITALITY & ENTERTAINMENT GROUP LLC for twenty-four (24) items, to wit:

ITEM NOS. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23 and 24.

This vendor has extended this contract to County Cooperative Contract System Participants, Identifier No. CK-02-OC.

2. Pursuant to N.J.A.C. 5:30-5.4, the County has established a reasonable estimated maximum dollar value of \$120,000.00 for the term of this contract, based on historical procurement data for comparable goods or services. The County further reserves the right to increase quantities by up to twenty percent (20%) of the maximum awarded amount at the unit prices bid, in accordance with N.J.A.C. 5:30-11.3.

3. Payments for the materials and equipment to be acquired by this contract shall be made upon the approval of vouchers submitted by the successful bidders in accordance with the requirements of the Board of Commissioners and subject to the Board of Commissioners customary procedures. Delivery shall be made upon receipt of a Purchase Order issued by the Ocean County Department of Purchase, upon which delivery locations and needed quantities shall be indicated.

4. Funds for these services shall be available within the following funding sources: Juvenile Services, Prosecutor's Office and Solid Waste Management.

5. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2026-10.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Juvenile Services, Prosecutor's Office, Solid Waste Management and the successful bidders.
