RESOLUTION

July 8, 2026

WHEREAS, there exists a need to provide One Stop Career Center Administrative Entity services for the Ocean County Local Workforce Area as required by the Workforce Innovation and Opportunity Act (WIOA); and

WHEREAS, on March 15, 2017, the Board of Chosen Freeholders adopted a resolution authorizing the use of competitive contracting for the procurement of One Stop Career Center Administrative Entity services; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, on July 2, 2024, a Competitive Contract was awarded to **Ocean County PIC, Inc.** and assigned Contract No. CC2024-85 to provide One Stop Career Center Administrative Entity Services, for the period of July 1, 2024 through June 30, 2025, with the option to extend for four (4) additional one-year periods; and

WHEREAS, due to guidance from the New Jersey Department of Labor, the option to extend the contract has been modified from four (4) additional one-year periods to three (3) additional one-year periods; and

WHEREAS, on July 2, 2025, the Agreement was extended for July 1, 2025 through June 30, 2026; and

WHEREAS, the Ocean County Department of Human Services desires to utilize the option to extend the Agreement for July 1, 2026 through June 30, 2027; and

WHEREAS, funds totaling \$3,501,769.00 shall be appropriated from the following accounts as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk are hereby authorized and directed to enter into and execute an extended Agreement with Ocean County PIC, Inc., 1959 Route 9,

Toms River, NJ 08755-1211, to provide One Stop Career Center Administrative Entity Services.

2. The contract number CC2024-85 must be placed on all papers, documents, invoices and vouchers pertaining to this Agreement.
3. A notice of this action shall be posted once as required by law.
4. A certified copy of this Resolution, together with a copy of the Amendatory Agreement, executed by both parties, shall be kept on file in the Office of the Clerk of the Board for public viewing during regular business hours.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to Ocean County Counsel, County Auditor, Department of Human Services, and Ocean County PIC, Inc.
