RESOLUTION

August 19, 2026

WHEREAS, on July 2, 2024, the Ocean County Board of Commissioners awarded an Agreement to Ocean County PIC, Inc., 1005 Hooper Ave, Toms River, NJ 08754 to provide One Stop Administrative Entity Services foy July 1, 2024 through June 30, 2025, with the option to extend for four (4) additional one-year periods, and was assigned Contract No. CC2024-85; and

WHEREAS on July 8, 2026, the Agreement was extended for an additional one-year period of July 1, 2026, through June 30, 2027, in an amount not to exceed \$3,501,769.00 from accounts maintained by the Ocean County Department of Human Services; and

WHEREAS, on July 8, 2026, due to guidance from the New Jersey Department of Labor, the option to extend the contract was modified from four (4) additional one-year periods to three (3) additional one-year periods; and

WHEREAS, additional funding has been made available and the modified contract amount is now increased to \$3,875,769.00, as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk are hereby authorized and directed to enter into and execute an Amendatory Agreement with Ocean County PIC, Inc., 1005 Hooper Ave. Toms River, NJ 08754, to provide One Stop Career Center Administrative Entity Services, for the period of July 1, 2026 through June 30, 2027, an increase to the contract of \$374,000.00.
2. The contract number CC2024-85 must be placed on all papers, documents, invoices and vouchers pertaining to this Agreement.
3. A notice of this action shall be posted once as required by law.
4. A certified copy of this Resolution, together with a copy of the Amendatory Agreement, executed by both parties, shall be kept on file in the Office of the Clerk of the Board for public viewing during regular business hours.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to Ocean County Counsel, County Auditor, Department of Human Services, and Ocean County PIC, Inc.
