RESOLUTION

May 3, 2023

WHEREAS, the COUNTY of OCEAN, has funds available for **Child and Adolescent Trauma Programming** which would facilitate training, consultation, and start-up associated with evidence-based trauma and prolonged grief clinical interventions for children and adolescents; and

WHEREAS, on December 7, 2022, the Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of **Child and Adolescent Trauma Programming**; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, the Ocean County Department of Human Services has received and reviewed proposals for the services listed above and recommends that an Agreement be awarded to **Bright Harbor Healthcare**, 687 Route 9, Bayville, New Jersey 08721 to provide such services, for May 1, 2023 through December 31, 2023, with an option to renew up to one (1) additional twelve (12) month period, as more specifically set forth in the Agreement; and

WHEREAS, funds up to the total amount of \$75,000.00 will be appropriated for these services, contingent upon the availability of funds, as follows:

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized to enter into an Agreement with **Bright Harbor Healthcare** to provide **Child and Adolescent Trauma Programming** contingent upon the availability of funds.

BE IT FURTHER RESOLVED, that the contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement, that number being CC 2023-74.

BE IT FURTHER RESOLVED, that the Director and the Clerk of the Board are hereby authorized and directed to execute any necessary subsequent related documents.

BE IT FURTHER RESOLVED, that a certified copy of this Resolution, together with a copy of the Agreement executed by the parties, shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.
