RESOLUTION

October 21, 2020

WHEREAS, the County of Ocean had awarded a contract to Atlantic Coast Fibers. LLC (a/k/a Atlantic Coast Recycling) pursuant to a Competitive Contract for the Recycling Facilities Operator in 2016, which was further amended in 2018; and

WHEREAS, part of the equipment replacement that was part of the County responsibility, namely the Ferrous Magnet, was delayed in both its manufacturing and its delivery/installation to the County Recycling Facility; and

WHEREAS, during March through December 2019, the County made Residue payments to the OC Landfill on behalf of Atlantic Coast Fibers, LLC which require repayment to the County; and

WHEREAS, a cost associated with the unforeseen delay in the installation of the Ferrous Magnet caused a calculable loss to Atlantic Coast Fibers, LLC; and

WHEREAS, both parties agree to accept the terms of the attached Agreement for Vendor Reimbursement Payments to Ocean County to settle these debts by permitting monthly installment payments by Atlantic Coast Fibers to the County.

NOW, THEREFORE, BE IT FURTHER RESOLVED, BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF OCEAN, STATE OF NEW **JERSEY AS FOLLOWS:**

- 1. The Freeholder Director and Clerk of the Board are hereby authorized to and directed to execute the Agreement for Vendor Reimbursement of Residue Payments.
