RESOLUTION

October 6, 2022

WHEREAS, on October 5, 2016, a contract for the Operation and Maintenance of the Ocean County Recyclable Materials Processing Facility was awarded to Atlantic Coast Fibers, LLC; and

WHEREAS, on December 19, 2018, a five (5) year contract extension was authorized for the period of 1/1/2022 through 12/31/2026; and

WHEREAS, Atlantic Coast Fibers, LLC has requested that the Operation and Maintenance of the Ocean County Recyclable Materials Processing Facility contract be reassigned to Atlantic Coast Recycling of Ocean County, LLC; and

WHEREAS, Atlantic Coast Recycling of Ocean County, LLC will assume all the obligations and responsibilities to the Operation and Maintenance of the Ocean County Recyclable Materials Processing Facility contract; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- The Director and Clerk of the Board are hereby authorized and directed to execute
 the company name amendment to the Operation and Maintenance of the Ocean
 County Recyclable Materials Processing Facility contract with Atlantic Coast
 Recycling of Ocean County, LLC for the remainder of the contract through
 December 31, 2026 with all other terms and conditions of the contract to remain in
 full force and effect.
- 2. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being <u>CC2016-127</u>.
- Copies of the Resolution shall be forwarded to Ocean County Comptroller, County Counsel, Director of Purchasing, Director of Solid Management, and Atlantic Coast Recycling of Ocean County, LLC.
