RESOLUTION

May 18, 2022

WHEREAS, on May 3, 2022, pursuant to legal advertisements therefor, one sealed bid was received for the furnishing and delivery of MOBILE RETAIL FOOD CONCESSIONS AT SPECIFIED COUNTY PARK LOCATIONS NO. II for the County of Ocean; and

WHEREAS, at the advertised time, one response was received from the following bidder:

WHEREAS, after the receipt and examination of same, the County Director of Purchase has now recommended to this Board that the sole bid received for Item No. 4 be rejected as unresponsive. No bids were received on Item Nos. 2, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, and 16 for the second time.

WHEREAS, N.J.S.A. 40A: 11-5(3) provides that, in the event no qualified bids are received on two occasions, a governing body may enter into a negotiable contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. Upon recommendation of the County Purchasing Agent, the sole bid received for Mobile Retail Food Concessions at Specified County Park Locations No. II, Item No. 4, is hereby rejected.

2. The County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the furnishing and delivery of Mobile Retail Food Concessions at Specified County Park Locations No. II, for all No bid Item Nos. 2, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, and 16 and rejected Item No. 4 for the County of Ocean for the contract period from date of award through April 19, 2025.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance; Parks Department and Taqueria Madrigal, LLC the sole bidder.
