WHEREAS, the County Engineer has now recommended to this Board that the sole qualified bid, according to specifications, namely that of, EDWARD H. CRAY, INC., be accepted for the 2025 On-Call Traffic Signal Maintenance Contract, Ocean County.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Edward H. Cray, Inc., accepting their bid in the total amount of \$374,177.00, in accordance with plans and specifications prepared by the County Engineer. The Contract shall be in effect for one (1) from January 15, 2025 through January 14, 2026, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the Contract pursuant to N.J.S.A. 40A: 11-15. The County reserves the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractor with no increase in base price.
- 2. The Department of Finance has certified that funds are available in Account No. 300-185-X305-6800 in the amount of \$374,177.00 to cover this contract, and the amount of the contract shall be encumbered against the said Appropriations.
