WHEREAS, the County of Ocean owns The Mary Etta Cox House County Historic Site, located in Barnegat Township, NJ; and

WHEREAS, the Department of Parks & Recreation desires to engage a firm to provide perform Construction Management services for The Interior Renovations at the Mary Etta Cox House (Phase 2), Barnegat Township, NJ; and

WHEREAS, the Consultant Selection Review Committee recommended ten (10) firms as qualified to provide Construction Project Management for Building and Site Development to be performed on an as-needed basis, where and as directed by Ocean County; and

WHEREAS, the Ocean County Board of Commissioners qualified the ten (10) firms as eligible to provide Construction Project Management for Building and Site Development by Resolution dated May 15, 2024 referred to as contract number QP2024-72; and

WHEREAS, the County of Ocean has received a proposal from Colliers Project Leaders, 101 Crawfords Corner Rd. Suite 3400 Holmdel New Jersey 07033; and

WHEREAS, Colliers Project Leaders submitted a proposal for Construction Project Management for Building and Site Development Services in the lump sum fee not to exceed ONE HUNDRED TWENTY FOUR THOUSAND ZERO DOLLARS AND ZERO CENTS (\$124,000.00); and

WHEREAS, funding is available for these services in the Redevelopment of Various Parks Account, Account No. 301-250-X321; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the County Purchasing Agent is hereby authorized to issue a Purchase Order for Construction Project Management for Building and Site Development Services to Colliers Project Leaders, to perform Construction Project Management Services for The Interior Renovations at Mary Etta Cox House (Phase 2), Barnegat Township, NJ, in an amount not to exceed ONE HUNDRED TWENTY FOUR THOUSAND ZERO DOLLARS & ZERO CENTS (\$124,000.00) from Redevelopment of Various Parks Account, Account No. 301-250-X321.
