**WHEREAS**, on July 11, 2024, a Resolution was adopted awarding a purchase order to M&M Construction Company, Inc. to provide for Construction Project Management for Building and Site Development for the Ocean County Justice Complex Annex, in an amount not to exceed \$2,000,000.00, under Contract No. QP2024-72; and

**WHEREAS**, it has been determined that additional Construction Project Management services be conducted in the project area; and

**WHEREAS**, M&M Construction Company, Inc. has provided a proposal for these additional services; and

**WHEREAS**, the not to exceed amount for these additional services is \$442,310.00; and
