WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Construction Project Management for Building and Site Development for the Ocean County Justice Complex Annex; and

WHEREAS, the Board considers it necessary and desirable to engage a firm from the list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on May 15, 2024 (QP2024-72); and

WHEREAS, M&M Construction Company Inc. is qualified to provide the required services in accordance with their project specific proposal at a cost not to exceed cost of \$2,000,000.00; and

WHEREAS, funds for these services shall be available from Account No. 301-010-X226; and

WHEREAS, this contract is awarded in compliance with the provisions of N.J.S.A. 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

NOW, THEREFORE, BE IT RESOLVED that the BOARD OF COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY hereby authorizes the issuance of a Purchase Order in the amount not to exceed \$2,000,000.00 to M&M Construction Company Inc. to provide Construction Project Management for Building and Site Development for the Ocean County Justice Complex Annex, with funding available from Account Number 301-010-X226.
