

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has now recommended to this Board that the lowest qualified bid, according to specifications, in each instance, be accepted namely that of, EARLE ASPHALT COMPANY and FIORE PAVING CO., INC. be accepted. Secondary contracts will be solicited from other bidders at the low bidder's rate. Services under secondary contracts will be requested from next low bidders until the needs of the County are met.
