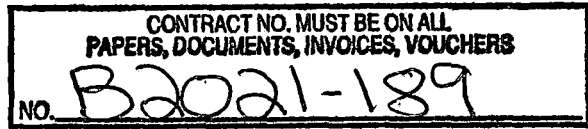

## RESOLUTION

July 6, 2022

WHEREAS, on October 26, 2021, pursuant to legal advertisements therefor, sealed bids were received for the furnishing and delivery of CATCH BASIN BLOCKS for the County of Ocean; and

WHEREAS, on November 17, 2021, Contract B2021-189, Item Nos. 1, 2, 3, 4, 5 and 6 were awarded to CONTINENTAL TRADING AND HARDWARE.

WHEREAS, the County Purchasing Agent has requested Contract B2021-189, Item Nos. 1, 2, 3, 4, 5 and 6 be rescinded as vendor is unable to honor their contract. This bid will be rebid with revised specifications; and
