RESOLUTION

December 18, 2024

WHEREAS, Contract No. B2024-01CE was entered into on January 17, 2024, with Ernest Bock & Sons, Inc., in connection with the project known as JUSTICE COMPLEX ANNEX OF OCEAN COUNTY, State of New Jersey; and

WHEREAS, it has been determined that revisions to the contract are necessary for additional work as outlined in:

- COR005R2: Relocate gas service for existing Cogen (CHP), gas meter pad and chain link fence for \$36,555.14; and
- COR008R1: Supply and install additional Call Box in Stair 3 as well as 2" dedicated gas line to boilers rather than original 4"x2" tee from generator line for \$6,685.82; and
- COR009R2: Supply and install additional hose bid and wall hydrant in boiler room per updated drawing PSK-005 for \$7,373.82; and
- COR013: Purchase of 30 additional Yodock Barriers for Hooper Avenue as requested by Owner for \$27.841.96; and
- COR014R2: Installation of new fuel tank and lines with demolition and removal of existing tank and lines and associated site and electric work required in preparation for JCP&L work for \$346,911.40; and
- COR021: Rigid Inclusion Phasing Plan to Begin Rigid Inclusions out of sequence and with additional mobilization cost for \$203,085.66; and

WHEREAS, the costs of the above referenced COR's in the amount of \$628,453.80 shall result in an increase to the contract sum; and

WHEREAS, the Consulting Architect, Clarke Caton Hintz P.C., has duly filed with the Board a request for Change Order stating the facts involved and certifying that the proposed Change Order is consistent with the regulations for such Change Orders promulgated by the State Department of Community Affairs Division of Local Government Services, under the authority of N.J.S.A. 52:27BB-32; and

WHEREAS, the Contractor has agreed to accept these changes to the Contract.

BOARD OF THEREFORE, IT RESOLVED, NOW, BE COMMISSIONERS, of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. The Contract amount shall be increased in the amount of \$15,183.89 from funding account #426-010-X324 and in the amount of \$613,269.91 from account #429-010-X324.
- 2. Clarke Caton Hintz P.C. is hereby authorized to issue Change Order No. 2 to Ernest Bock & Sons, Inc., in connection with the project known as Justice Complex Annex of Ocean County.
- 3. That the Director and Clerk of the Board are hereby authorized and directed to enter into an Amendatory Contract with Ernest Bock & Sons, Inc., 2800 Southampton Road, Philadelphia, PA 19154 to cover Change Order No. 2 and to provide additional information and furnish such documents as may be required.
- 4. The Contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2024-01CE.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Management & Budget Department, Finance Department, Purchasing Department, Buildings & Grounds Department, County Auditor, Clarke Caton Hintz P.C. and Ernest Bock & Sons, Inc.
