RESOLUTION

WHEREAS, on November 18, 2025, pursuant to legal advertisements therefor, sealed bids were received for furnishing and delivery of AGRICULTURAL SUPPLIES for the County of Ocean; and

WHEREAS, on December 17, 2025, Contract B2025-190, Item No. 41 was awarded to HERITAGE LANDSCAPE SUPPLY GROUP, INC., and

WHEREAS, the County Purchasing Agent has now requested Contract B2025-190, Item No. 41 awarded to HERITAGE LANDSCAPE SUPPLY GROUP, INC be rescinded due to vendor being unable to honor their contract pricing.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The aforementioned Resolution and Contract dated December 17, 2025 awarding Item No. 41 to HERITAGE LANDSCAPE SUPPLY GROUP, INC , is hereby rescinded.

2. The Director and Clerk of this Board are hereby authorized and directed to enter into an amendatory contract with NOBLE TURF LLC for Item No. 41, the next lowest qualified bidder. This vendor has extended the contracts to County Cooperative Contract System Participants, Identifier No. CK-02-OC. All orders placed through the cooperative must reference the County Cooperative Identifier No. CK-02-OC.

3. All other provisions of Contract No. B2025-190 shall remain in full force and effect.

4. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2025-190.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Purchasing Department, Finance Department, Buildings & Grounds Department, Parks Department and Noble Turf LLC, the successful bidder.
